


Livestock review - Pig

Pig population from 2015-2016





Pork production of VN from 1990 to 2014 and projection of 2020 (in '000 tons)




Sow population of Vietnam in 2007-2016.




Price of exotic piglet





(kg/hd)**




Relative Shares Of Meat Consumption, 2004-2016f



This indicates that pig production plays an important role in the livestock production as pork production now occupies **72.4%** of the total meat production consumed in Vietnam.



Year 2014

- Sow on Hand = 4.13 Mil
- Sow on Prod = 3.717 Mil
- 30% Exotic = $3.717 \times 0.3 = 1.115$ Mil
 - P/S/Y at market = **20** X 1.115 = 22.302 Mil
 - Pork meat = $22.302 \times 75 = 1.672$ Mil ton
- 70% Local = $3.717 \times 0.7 = 2.60$ Mil
 - P/S/Y at market = **13** X 2.60 = 33.8 Mil
 - Pork meat = $33.8 \times 65 \times .75 = 1.647$ Mil ton
- Total Pork meat = 3.319 Mil ton
- Or consumption = 36.87 kg /capita/year

Forecast pig market situation 2017-2020

- In 2015 & 2016, fattening pigs export to China so much (about 5 - 6 mil pig/year) with high price, so pig population in VN increase (about 10-15%)
- But at the end 2016 the export fast down, so fattening pig's price low down (from 50.000 VND/kg down to 35.000 VND/kg). This situation, in 2017 quantity of pig in VN will reduce (15 – 20%).

Prevention FMD

- Standard Farm (10 Licenses)
- Practice Rule regulation law
- Program Vac FMD at least 2 times/year
- Quarantine 21 days (local) 45 days (import)
(no docs → destroy)
- Only Vet is able to inject
- Transfer Ear tag

Pig Genetic Centre Vietnam

VDL Agrotech has recently completed a pig project in Vietnam for the Dutch company de Heus.

The boars from Topigs-Norsvin are imported from France and are already in production.

Besides high quality feed de Heus can also supply now high quality genetics to the Vietnamese market.

It is the most modern pig genetics centre in south east Asia and contains 120 boars, a semen collection area and a laboratory for analysing and packing.



The Hi Tech laboratory.

The centre is located in Binh Duong and isolated from other pig farms. It has an extremely high biosecurity level with an overpressure ventilation system and anti-virus filters for incoming air. The active airco-system guarantees always a comfortable 20 Celsius temperature inside with a low humidity.

Vietnam's integration

- ASEAN Economic Community
 - From 2018, the livestock sector of Viet Nam would face fierce competition from Asian producers when the tariffs and Non-tariff barriers to trade are reduced and removed thanks to FTAs: 3-5%
 - Viet Nam's livestock sector's difficult conditions:
 - **size of production is small,**
 - slaughter hygiene and food safety remain limited, causing food poisoning,
 - **disease-stricken problem is common though still under control ...**

Vietnam's integration

- Free trade agreement with EU (EVFTA)
 - While Vietnam struggles with scandals about banned substances and high antibiotic residue, Meat imports from Europe, Australia, America have begun dominating the domestic market in high segment.
 - At present, the tariff on meat imports from the EU is **14-30%**. But it will be applied **EVFTA from 2018** with scheduled:

Vietnam's tariff scheduled with EU		
1	Frozen pork	Remove tariff within 7 years
2	Cattle meat	Remove tariff within 3 years
3	Chicken meat	Remove tariff within 10 years
4	Dairy product	Remove maximum tariff within 5 years
